## Message From Walker Aggregates Vice-President/General Manager

Our company has a new name. As a result of a reorganization of the subsidiaries that are part of Walker Industries Holdings Limited, Georgian Aggregates no longer exists as a separate entity.

Georgian is now under the umbrella subsidiary company called Walker Aggregates Inc. Also part of Walker Aggregates Inc. are the Vineland Quarry, Walker Brothers Quarries in Niagara Falls, Ridgemount Quarries in Fort Erie and Walker Brothers Asphalt in Niagara Falls.

The name Georgian Contracting has been changed to Georgian Paving and Construction. This operation has become a division of Walker Aggregates Inc.

The changes are part of an effort to streamline the various divisions of Walker's operations.

I will continue to have responsibility for the operations within Walker Aggregates Inc. as vice-president. Our holding company, Walker Industries Holdings Limited has a new president, John Fisher (see story on page 2).

We continue to await comments from government bodies and agencies on the proposed Duntroon Quarry expansion. Some of the commenting agencies have been asking questions about our proposal and requesting more information, which we have been pleased to supply.

Last year was a good year for business for our Duntroon Quarry. We had our busiest month in the quarry's history in November due to the mild fall weather. The entire year was a good one for our stone extraction and sales, and we expect more of the same in 2007.

Plans for this current winter season include relocating the crushing plant to the bottom of the Quarry floor. It will be located 14 feet below grade with more enclosures installed to further minimize noise.

This will simulate how the crushing plant will operate in our proposed new quarry expansion. The new quarry will also have its crushing plant located below grade.

## Presentations Made for Asphalt Plant Relocation

It was standing room only at the Clearview Township Office during a Planning Committee meeting on January 22, 2007. On that evening, a team from Walker Aggregates made a presentation on its application for rezoning and an official plan amendment to relocate its asphalt plant from the Duntroon Quarry to a new site in Staynor.

Walker Aggregates requires the changes from the township and Simcoe County, as well as approval from the Ministry of the Environment, to move its plant to a 15-acre parcel of land it has purchased on 27/28 Side Road in the north end of Staynor.

Presentations were made to council by planner Brent Clarkson, asphalt plant manager Bob Buckley and Walker Aggregates vice-president and general manager Ken Lucyshyn.

Neighbours in attendance questioned the plant location, wondering why the site was chosen and expressing concerns over such impacts as truck traffic and noise.

The Walker team explained that it explored 26 possible sites before settling on the current one, which was the most suitable because it had access to hydro and natural gas supplies, and was located far from residential developments. The site is adjacent to the township yard and sewage lagoons.

The Walker team also explained that at peak capacity, which would occur only occasionally, there would be a maximum of 18 trucks per hour entering and exiting the site.

The Clearview Township Planning Committee is now considering the application.

## Walker Industries Appoints New President
