Message from Walker Aggregates' Vice-President

Work is continuing on all of the tasks that need to be completed before we can begin the Duntroon Quarry expansion. These include completing the Adaptive Management Plan (AMP), amending the site plan in accordance with the Consolidated Hearings Board directives, obtaining a development permit from the Niagara Escarpment Commission (NEC), completing work on nearby road upgrades, obtaining a Permit to Take Water, completing an inventory of butternut trees on the site and installing surface water monitors.

The expansion property has been surveyed for fences to be erected before site work occurs.

We've received comments on the AMP from the Ministry of Natural Resources and are now awaiting sign-off from the conservation authorities and Clearview Township, after responding to issues they had raised. We've also received a cheque for \$15,000 from the NEC to help cover our costs for the Judicial Review hearing, as directed by the Ontario Superior Court of Justice.

In the meantime, Marie Millar, our neighbour across County Road 91 has moved out of her home on the expansion lands. Marie and her late husband Dalton built the homestead almost 40 years ago and raised their four children there. While now living in a retirement community down the road in Stayner, Marie will always be a part of the extended Walker family, and will continue to be a welcome guest at all of our community events.

The Millar home is almost as close to our hearts as it is to Marie, her children and grandchildren, and we would like to move our office there. This move is subject to the NEC issuing us a development permit to change the use of the building from residential to office.

Our plan is to tear down the existing office in the coming weeks, so we can remove the rock underneath. The edge of the quarry is now only a few metres away from the office.

With the biggest hurdles of the quarry expansion behind us, we're looking forward to moving a bit more quickly on the next phase of our aggregate operations in Duntroon.

With the end of summer and the fall season upon us, I hope to see many of our friends and neighbours at our holiday reception in November (see details on page 2).
