
Consider the social aspects, such as:

Seek products and services that:

- ✓ Are locally sourced
- ✓ Are accessible
- ✓ Are designed for the environment
- ✓ Are manufactured with re-manufacturing in mind
- ✓ Use non-hazardous materials
- ✓ Use recycled raw materials
- ✓ Maximize use of bio-based or recycled materials
- ✓ Conserve energy, water and resources
- ✓ Reduce waste generation (garbage, emissions, waste water)
- ✓ Reduce the consumption or disposal of hazardous materials



Consider the following environmental performance characteristics:

- ✓ Biodegradable
- ✓ Carcinogen-free
- ✓ Chlorofluorocarbon free
- ✓ Compostable
- ✓ Durable
- ✓ Heavy metal free (e.g., no lead, mercury, cadmium)
- ✓ Free of volatile organic compounds
- ✓ Non-toxic
- ✓ Made from rapidly renewable materials
- ✓ Persistent, bio-accumulative toxic-free
- ✓ Made from recycled content
- ✓ Reduced greenhouse gas emissions
- ✓ Less hazardous
- ✓ Locally manufactured
- ✓ Reduced packaging
- ✓ Refurbished
- ✓ Resource efficient
- ✓ Energy efficient
- ✓ Water efficient
- ✓ Reusable
- ✓ Upgradeable
