E. Inert Fill Acceptance Agreement

Agreement of Inert Fill Acceptance:
 WHEREAS Walker Aggregates Inc ("the site") has agreed to accept Inert Fill / Materials for the purpose of Quarry Rehabilitation from the "Excavation Site" and the "Customer" ("the customer") . IN CONSIDERATION of the acceptance of such materials and the payment therefore, the parties agree as follows:

- The Term "Inert Fill" and "Material(s)" refers to earth or rock fill or materials of similar nature that contain no putrescible materials or soluble or decomposable substances
- The Customer warrants that all Inert Fill deposited by or on behalf of the customer at the site contains no contamination that would cause the material to be classified as a waste under Reg. 347 or "contaminated" under Ministry of Environment Regulation 153/04 and Table 1 of the document titled "Soil, Ground Water and Sediment Standards for Use Under Part XV.1 of the Environmental Protection Act",
- All Materials brought to "the site" contains no substance in a concentration greater than the limits described in Table 1 of the document titled "Soil, Ground Water and Sediment Standards for Use Under Part XV.1 of the Environmental Protection Act", and contains no other material / contaminants that would pose an environmental hazard to "the site"
- The Customer warrants that it will not deposit at the site any materials prohibited by Ministry of Environmental, Ministry of Natural Resources Regulations
- Should any illegal or unacceptable materials be found in any load, or, after deposited in the site and traced to the Customer, the Customer authorizes Walker Aggregates Inc to have such illegal/unacceptable materials removed from "the site" at the Customer's expense, and undertakes to pay such charges forthwith.
- The Customer undertakes to advise Walker Aggregates Inc of the source of any illegal/unacceptable materials delivered to the site.
- The Customer will indemnify and save harmless Walker Aggregates Inc and any of its subsidiary companies from any loss, damage, action, prosecution, fine, costs, expenses (including the expenses of defending any such action or prosecution), or other costs to which Walker Aggregates Inc may be put as a result of any misrepresentation by the customer or the deposit of any illegal/unacceptable materials by or on behalf of the customer at the site
